  - (a) up to a maximum aggregate nominal amount of £8,796,021 (representing approximately one third of the Company's issued ordinary share capital); and
  - (b) comprising equity securities (as defined in section 560(1) of the Companies Act 2006) up to an aggregate nominal amount of £8,796,021 (representing approximately one third of the Company's issued ordinary share capital) (that amount to be reduced by the aggregate nominal amount of shares allotted or Rights granted under paragraph (a) of this Resolution) in connection with an offer by way of a rights issue:
    - to ordinary shareholders in proportion (as nearly as may be practicable) to their existing holdings;
       and
    - to holders of other equity securities as required by the rights attaching to those securities, or subject to those rights, as the Directors otherwise consider necessary,

and so that the Directors may impose any limits or restrictions and make any arrangements which they consider necessary or appropriate to deal with treasury shares, fractional entitlements, record dates, legal, regulatory or practical problems in, or under the laws of, any territory or any other matter, such authorities to expire (unless previously renewed, varied or revoked) at the end of the next annual general meeting of the Company after this resolution 16 is passed or, if earlier, at the close of business on 21 June 2020 but, in each case, so that the Company may make offers and enter into agreements before that expiry which would, or might, require shares to be allotted or Rights to be granted after that expiry and the Directors may allot shares or grant Rights pursuant to any of those offers or agreements as if the authority had not expired.

#### Disapplication of pre-emption rights

- 17 That, in substitution for all existing powers and subject to the passing of Resolution 16 above, the Directors are generally empowered pursuant to section 570(1) of the Companies Act 2006 to allot equity securities for cash pursuant to the general authority conferred on them by Resolution 16 as if section 561 of the Companies Act 2006 did not apply to that allotment. This power:
  - (a) shall be limited to the allotment of equity securities in connection with an offer of equity securities (but in the case of an allotment pursuant to the authority in paragraph (b) of Resolution 16 by way of rights issue only):
    - to ordinary shareholders in proportion (as nearly as may be practicable) to their existing holdings;
    - (ii) to holders of other equity securities as required by the rights attaching to those securities, or subject to those rights, as the Directors otherwise consider necessary,

and so that the Directors may impose any limits or restrictions and make any arrangements which they consider necessary or appropriate to deal with treasury shares, fractional entitlements, record dates, legal, regulatory or practical problems in, or under the laws of, any territory or any other matter; and

- (b) shall be limited to the allotment of equity securities for cash pursuant to the authority in paragraph (a) of Resolution 16 (otherwise than in the circumstances set out in paragraph (a) of this Resolution 17) up to an aggregate nominal amount of £1,319,403, and
- (c) expires (unless previously renewed, varied or revoked) at the end of the next annual general meeting of the Company after this resolution is passed or, if earlier, at the close of business on 21 June 2020 but so that the Company may make offers and enter into agreements before that expiry which would, or might, require equity securities to be allotted after that expiry and the Directors may allot equity securities pursuant to any of those offers or agreements as if this power had not expired; and
- (d) applies in relation to a sale of shares which is an allotment of equity securities by virtue of section 560(3) of the Companies Act 2006 as if in the first paragraph of this Resolution 17 the words "pursuant to the general authority conferred on them by Resolution 16" were omitted.

For the purposes of this Resolution 17, the expression "equity securities" and references to "allotment of equity securities" respectively have the meanings given to them in section 560 of the Companies Act 2006.

#### Market purchases

- 18 That the Company be generally and unconditionally authorised:
  - (a) for the purposes of section 701 of the Companies Act 2006 to make one or more market purchases (within the meaning of section 693(4) of the Companies Act 2006) of ordinary shares in the capital of the Company on such terms and in such manner as the Directors shall from time to time determine, provided that:
    - (i) the maximum aggregate number of ordinary shares hereby authorised to be purchased is 52,776,127 (representing approximately 10 per cent of the Company's issued ordinary share capital);
    - (ii) the minimum price (exclusive of any expenses) which may be paid for an ordinary share is not less than its nominal value;
    - (iii) the maximum price which may be paid for an ordinary share is in respect of an ordinary share contracted to be purchased on any day, not more than the higher of:
      - (A) an amount (exclusive of any expenses) equal to 105 per cent of the average of the middle market quotations of an ordinary share (as derived from the London Stock Exchange plc's Daily Official List) for the five business days immediately preceding the date on which that ordinary share is contracted to be purchased; and
      - (B) an amount (exclusive of any expenses) equal to the higher of (i) the price of the last independent trade of an ordinary share; and (ii) the highest current independent bid for an ordinary share on the London Stock Exchange at the time the purchase is carried out; and
    - (iv) the authority hereby conferred shall expire at the conclusion of the next Annual General Meeting of the Company following the passing of this resolution or, if earlier, at the close of business on 21 June 2020 but the Company may make a contract of purchase of any ordinary shares which would, or might, be concluded wholly or partly after that expiry and may make a purchase of ordinary shares pursuant to such a contract as if this authority had not expired; and
  - (b) pursuant to section 724 of the Companies Act 2006 to hold as treasury shares any ordinary shares purchased pursuant to the authority conferred in paragraph (a) of this Resolution 18.

#### Notice for general meetings

19 That for the purpose of section 307A of the Companies Act 2006, the Directors be authorised to call general meetings of the Company other than annual general meetings on not less than 14 clear days' notice, provided that this authority shall expire at the conclusion of the Company's 2020 annual general meeting.

- Shareholders entitled to attend, speak and vote at this meeting may appoint one or more proxies to attend and, on a poll, vote in their place. A proxy need not be a shareholder of the Company. If a shareholder appoints more than one proxy to attend this meeting, each proxy must be appointed to exercise the rights attached to a different share or shares held by the shareholder. As at 6 February 2019 being the last practicable date prior to the publication of this Notice, the Company's issued share capital consisted of 527,761,271 ordinary shares of five pence each ("Ordinary Shares"), none of which were held in treasury. The total voting rights in the Company as at 6 February 2019 was 527,761,271.
- 7 Copies of the following documents will be available for inspection at the registered office of the Company during usual business hours on any weekday (Saturdays, Sundays and Bank Holidays excluded) until the date of the AGM and also on the date and at the place of the AGM from 12.30pm until the conclusion of the AGM:

#### Explanatory Notes on the Business of the AGM

## Resolution to Receive the Annual Report and Accounts for the financial year ended 31 December 2018 and the Directors' Report and Auditors' Report on these (Resolution 1)

The Directors are required to present to the AGM the accounts, and the reports of the Directors and auditors, for the financial year ended 31 December 2018. These are contained in the Company's Annual Report and Accounts 2018.

## Resolution that the Directors' Remuneration Report for the financial year ended 31 December 2018 be approved (Resolution 2)

The Company is required under section 439 of the Companies Act 2006 to ask shareholders to approve the Directors' Remuneration Report which is included in the Annual Report and Accounts 2018. These can be viewed on the Company's website and are available to shareholders on request. The resolution is advisory and does not affect the remuneration paid to any Director.

The Company's auditors, for the financial year ended 31 December 2018 KPMG, have audited those parts of the Directors' Remuneration Report which are required to be audited and their report may be found in the Annual Report and Accounts.

#### Resolutions to approve the payment of a second interim dividend (Resolution 3)

That the payment of a second interim dividend of 7.8 pence per ordinary share be approved and paid on 27 March 2019 to shareholders on the register of members on 1 March 2019.

#### Re-election of Directors (Resolutions 4 to 13 inclusive)

In compliance with the provision on annual re-election of all Directors introduced by the UK Corporate Governance Code, all Directors wishing to seek re-election are submitted for re-election and are recommended by the board. The Board currently has 11 Directors (comprising a non-executive Chairman, three Executive Directors and seven other non-executive Directors), whose experience and expertise are derived from a range of industries, sectors and personal characteristics that provide an invaluable perspective on the Company's business. Biographical details for each Director, including their career history and experience can be on pages 82 to 83 of the 2018 Annual Report and at www.beazley.com.

George Blunden will be stepping down from the Board following the AGM and is therefore not seeking re-election.

The Nomination Committee, which is the committee of the Board which considers the balance of the Board and the mix of skills, knowledge and experience of its members, has considered and approved the proposed re-election of Angela Crawford-Ingle, Christine LaSala, Sir Andrew Likierman, David Roberts, John Sauerland, Robert Stuchbery and Catherine Woods. All the proposed appointees have been subject to a formal evaluation procedure in the last 12 months.

Following that evaluation procedure, the Chairman confirms the continuing commitment and effective contribution of Angela Crawford-Ingle, Christine LaSala, Sir Andrew Likierman, John Sauerland, Robert Stuchbery and Catherine Woods to their roles and recommends their re-election.

#### Auditors (Resolutions 14 and 15)

The Company is required, at each annual general meeting at which accounts are presented, to appoint auditors to hold office until the next such meeting. The Company held a competitive tender in 2018, to appoint a new auditor. Details of the process are set out in the 2018 Annual Report pages 94 to 95 and EY were selected to be the Company's new auditors for the 2019 audit. Accordingly, Resolution 14 proposes the appointment of EY as the auditors to the Company following the recommendation of the Audit and Risk Committee.

Resolution 15 authorises the Audit and Risk Committee to determine EY's remuneration.

#### Authority of Directors to allot shares (Resolution 16)

Under the Companies Act 2006, the Directors may only allot shares or grant rights to subscribe for, or convert any security into, shares if authorised to do so by the shareholders in general meeting. Accordingly, resolution 16 seeks to grant an authority under section 551 of the Companies Act 2006 to authorise the Directors to allot shares in the Company or grant rights to subscribe for, or convert any security into, shares in the Company. This resolution will expire at the conclusion of the next Annual General Meeting of the Company or, if earlier, 21 June 2020. Upon the passing of this resolution, the Board will have authority (pursuant to paragraph (a) of the resolution) to allot relevant securities up to a maximum aggregate nominal amount of £8,796,021 representing approximately one third of the current issued ordinary share capital of the Company as at 6 February 2019, being the latest practicable date before the publication of this Notice. In addition, in accordance with the latest institutional guidelines from the Investment Association ("IA") on the expectations of institutional investors in relation to the authority of Directors to allot shares, upon the passing of this resolution the Board will have authority (pursuant to paragraph (b) of the resolution) to allot an additional number of ordinary shares up to a maximum aggregate nominal amount of £17,592,042, which is approximately a further third of the current

issued ordinary share capital as at 6 February 2019 being the latest practicable date before the publication of this Notice. However, the Directors will only be able to allot those shares for the purposes of a rights issue in which the new shares are offered to existing shareholders in proportion to their existing shareholdings.

As a result, if this resolution is passed, the Board could allot shares representing up to two-thirds of the current issued ordinary share capital pursuant to a rights issue.

There is no present intention of exercising this authority except in connection with the Company's employee share schemes. However, it is considered prudent to maintain the flexibility that this authority provides. If they do exercise the authority, the Directors intend to follow emerging best practice as regards its use as recommended by the IA.

As of 6 February 2019, being the last practicable date prior to the publication of this Notice, the Company did not hold any treasury shares.

#### Disapplication of pre-emption rights (Resolution 17)

Under section 561(1) of the Companies Act 2006, if the Directors wish to exercise the authority under Resolution 16 and allot any shares for cash, or grant rights to subscribe for, or convert securities into, shares, they must offer them in the first instance to existing shareholders in proportion to their existing shareholdings. In certain circumstances, it may be in the best interests of the Company to allot new shares (or to grant rights over shares) for cash without first offering them to existing shareholders in proportion to their shareholdings. This cannot be done under the Companies Act 2006 unless the shareholders have first waived their pre-emption rights.

This resolution, which is to be proposed as a special resolution and which is conditional on Resolution 16 having been passed, asks the shareholders to do this by allowing the Directors to allot shares (including treasury shares) for cash (i) by way of a rights issue in which the new shares are offered to existing shareholders in proportion to their existing shareholdings; and (ii) to persons other than existing shareholders up to a maximum aggregate nominal amount of £1,319,403; which is equivalent to 5 per cent of the nominal amount of the issued share capital of the Company on 6 February 2019 being the latest practicable date prior to the publication of this Notice.

If given, the authority will expire at the conclusion of the next Annual General Meeting in 2020 or, if earlier, 21 June 2020. The Directors intend to renew such power at subsequent Annual General Meetings in accordance with current best practice.

The Directors have no current plans to allot shares, except in connection with employee share schemes. In accordance with The Pre-Emption Group's Statement of Principles, the Directors confirm that they do not intend to issue more than 7.5 per cent of the issued ordinary share capital of the Company on a non pre-emptive basis in any rolling three-year period without prior consultation with the relevant investor groups.

#### Authority for the Company to purchase its own shares (Resolution 18)

This Resolution gives the Company the authority to buy back Ordinary Shares in accordance with the Companies Act 2006. The maximum aggregate number of Ordinary Shares that may be purchased pursuant to this authority will be limited to 52,776,127 Ordinary Shares, which represents approximately 10 per cent of the Company's issued ordinary share capital as at 6 February 2019, being the latest practicable date before the publication of this Notice. The authority would expire at the conclusion of the 2019 Annual General Meeting or, if earlier, 21 June 2020. The Board intends to seek renewal of this power at subsequent Annual General Meetings in accordance with current best practice.

The minimum price (excluding expenses) that may be paid by the Company for an Ordinary Share is its nominal value and the maximum price which may be paid by the Company for an Ordinary Share is the higher of:

- (a) an amount (excluding expenses) equal to 105 per cent of the average of the middle market quotations of an Ordinary Share (as derived from the London Stock Exchange Daily Official List) for the five business days immediately preceding the date on which that Ordinary Share is contracted to be purchased; and
- (b) an amount (excluding expenses) equal to the higher of (i) the price of the last independent trade of an Ordinary Share; and (ii) the highest current independent bid for an Ordinary Share on the London Stock Exchange at the time the purchase is carried out.

Any buy back of Ordinary Shares would be made on the London Stock Exchange.

The Directors will exercise this power only when, in the light of market conditions prevailing at the time, they believe that the effect of such purchases will be in the best interests of shareholders. The Directors consider it to be desirable for this general authority to be available to provide flexibility in the management of the Company's capital resources over the next 12 months. In addition, other investment opportunities, appropriate gearing levels and the overall position of the group will also be taken into account when determining whether to exercise this authority.

The Company may hold in treasury any of its own shares that it purchases pursuant to the authority conferred by this resolution. This gives the Company the ability to reissue treasury shares quickly and cost-effectively and provides the Company with greater flexibility in the management of its capital base. It also gives the Company the opportunity to satisfy employee share scheme awards with treasury shares. Accordingly, if the directors exercise the authority conferred by this resolution, the Company will have the option of holding those shares in treasury, rather than cancelling them. The Directors will have regard to any guidelines published by investor groups in force at the time of any market purchase, holding or resale of treasury shares.

In the financial year ended 31 December 2018, the Company did not purchase any of its own shares. In the period from 1 January 2019 to 6 February 2019 (being the latest practicable date prior to the publication of this Notice), the Company did not purchase any of its own shares.

The total number of options to subscribe for shares outstanding as at 6 February 2019 being the latest practicable date before the publication of this Notice, was 16,298,218. This represents 3.1 per cent of the issued share capital at that date. If the Company was to buy back the maximum number of Ordinary Shares permitted pursuant to this resolution, then the total number of options to subscribe for Ordinary Shares outstanding at 6 February 2019 would represent 3.4 per cent of the reduced share capital.

#### Notice period for general meetings (Resolution 19)

The Companies (Shareholders' Rights) Regulations 2009 (the "Shareholders' Rights Regulations") increased the notice period for general meetings to 21 clear days unless shareholders approve a shorter period, which cannot be less than 14 clear days. Resolution 19 seeks the approval of shareholders to grant the authority to be able to call general meetings (other than an Annual General Meeting) on not less than 14 clear days' notice. The flexibility offered by Resolution 19 will be used where, taking into account the circumstances, the Directors consider this appropriate in relation to the business to be considered at the meeting and in the interests of the Company and shareholders as a whole. In doing so, the Directors will note the recommendations of the UK Corporate Governance Code.

The Company will meet the requirements for electronic voting under the Shareholders' Rights Regulations before calling a general meeting on less than 21 clear days' notice. If given, the approval will be effective until the Company's next Annual General Meeting, when it is intended that a similar resolution will be proposed.
